9. For guaranteed hotel bookings paid upon stay, eligibility for the travel statement credit will only be validated after successful completion of the trip and hotel check-out confirmation.
10. Supplementary Card spend under the same account relationship may contribute toward the qualifying spend threshold, provided all eligible transactions are billed under the same Primary Platinum Card account.
11. The USD 300 travel statement credit will be credited to the Primary Platinum Cardmember account only.
12. The travel statement credit is non-transferable and cannot be exchanged for cash, Membership Rewards® points, vouchers, credits, or any alternative benefit.
13. Eligible transactions must be successfully posted and reflected within American Express Saudi Arabia systems to qualify for this benefit.

Online bookings, third-party travel agencies, or bookings made outside approved servicing channels are not eligible unless otherwise approved by American Express Saudi Arabia.
